ORDINANCE NUMBER: SRO-604-2026

TECHNICAL AMENDMENTS TO THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY CODE OF ORDINANCES TO REFERENCE QUARTERLY GENERAL WELFARE PAYMENTS FOR PURPOSES OF CHILD SUPPORT, SPOUSAL SUPPORT, RESTITUTION, COURT ORDERED FINES, AND OTHER PROGRAMS.

BE IT ENACTED THAT:

This ordinance amends the following sections in the SRPMIC Code of Ordinances:

Chapter 1. Article V. Local Emergencies and Disasters

Sec. 1-503 (a) after the term “per capita distributions” in the third sentence and after “per capita” in the fourth sentence, add “or quarterly general welfare payments”.

Chapter 2. Article III. Removal from Membership Rolls.

Sec. 2-55(6)(b) after “per capita distributions”, add “or general welfare payments”, and in Sec. 2-56(4) after “per capita distributions”, add “or general welfare payments”.

Chapter 3. Article I. General

In Sec. 3-5(b)(4)(e) after “per capita distribution”, add “or quarterly general welfare payment”.

**Chapter 10. Domestic Relations, Article II. Marriage, Divorce, Annulment, Separate Maintenance,
Division 2. Child Support**

In Sec. 10-50 in the definition of “income”, after the word “income” add “, for purposes of child support governed by this Chapter 10,”; and after the term “per capita payments”, add “, quarterly general welfare payments,”

Sec. 10-62(b)(4) after the term “per capita”, add “, quarterly general welfare payments”.

Sec. 10-65(a) after the term “per capita payments” add “or quarterly general welfare payments”.

Sec. 10-65(c) in the "Notice" section, after the term "per capita" add ", quarterly general welfare payments".

Sec. 10-66(e) after the term "per capita payments" add "or quarterly general welfare payments"; and then after the term "per capita" add "or quarterly general welfare payments".

Chapter 15.6 Minors and Protected Person's Trusts

Chapter 15.6 rename the Chapter, "Minors and Protected Person's Trusts and Internal SRPMIC General Welfare Processes"

Sec. 15.6-1 Change the heading to "Trust protection for minor and incompetent beneficiaries receiving per capita or quarterly general welfare payments".

Sec. 15.6-1(b), remove "under the act".

Also in 15.6-1(c) remove "under the Act".

In Sec. 15.6-1(f), remove "pursuant to the Act".

Sec. 15.6-2 after "per capita IGRA payment" add "or quarterly general welfare payment". Also, in the first sentence also strike, "under the Act".

Chapter 16. Traffic and Motor Vehicles, Article VI. Operation of Vehicles Division 5. Driving Under the Influence; Reckless Driving

Sec. 16-231(k) after the word "income" add ", asset".

Chapter 20. Finances

Sec. 20-1 all references to "per capita" should have "or quarterly general welfare payment" after it.

Article V. Unclaimed Personal Property

Sec. 20-114(a)(1) after "per capita" in the middle of sentence and at the end of the sentence should have "or quarterly general welfare payment" after it.

Sec. 20-114(a)(2) after "per capita distributions" should have "quarterly general welfare payments" after it.

C E R T I F I C A T I O N

This Ordinance is hereby enacted pursuant to the authority contained in Article VII, Section ___ of the Constitution of the Salt River Pima-Maricopa Indian Community ratified by the Tribe, February 28, 1990, and approved by the Secretary of the Interior, March 19, 1990, and amended by the Tribe, February 27, 1996, and approved by the Secretary April 23, 1996, the foregoing Ordinance was adopted this 11th day of March, 2026, in a duly called meeting held by the Community Council in Salt River, Arizona at which a quorum of 8 members were present by a vote of 8 for; 0 opposed, 0 abstentions, and 1 excused.
