27 Petitioner, Salt River Pima-Maricopa Indian Community Police Department
28 (hereinafter "SRPD" or "Community") through undersigned counsel hereby moves the
29 Court to issue an order forfeiting abandoned¹ firearms to the Salt River Police
30 Department, ("SRPD") pursuant to the Salt River Pima-Maricopa Indian Community
31 ("Community") Code of Ordinances Chapter 20, Article V: Unclaimed Personal Property
32 § 20-117. The Community further moves the Court to set a disposition hearing date for
33 the property and to publish notice of the hearing date as determined appropriate by the

2 (d).

3 For cause of action the Petitioner states the following:
4

5 The Salt River Pima-Maricopa Indian Community Court has jurisdiction in this
6 matter pursuant to §4-1 of the SRPMIC Code of Ordinances incorporated herein by this
7 reference.

8 Attached as "Exhibit A" is a List of Firearms, ("SRPD List") that have been in
9 SRPD's possession for over 180 days after being located, retrieved or received by a
10 Community department and presumed to be abandoned pursuant to § 20-112 (a)(2) of
11 the Community Code of Ordinances.

12 The firearms in the SRPD List are currently in the protective custody of the
13 Community government pursuant to § 20-112 (b) of the Community Code of
14 Ordinances, specifically stored in the SRPD Property and Evidence Bureau ("PEB"), a
15 secured location. The SRPD List includes:

- 16 1. A description of the firearm (Column 4 - Description/Date of Impoundment with
17 PEB).
- 18 2. The date each of the firearms came into possession by SRPD (Column 4 -
19 Description/Date of Impoundment with PEB).
- 20 3. A description of how SRPD came to be in possession of the firearms (Column 3 -
21 Property Code).
- 22 4. Any claims made for a firearm by any person (Column 5 – Claims Made).
- 23 5. Firearms which have been voluntarily turned over to the SRPD as well as
24 firearms that have been found within the community's boundaries with no
25 apparent owner or addresses available.

1 **WHEREFORE** the Community respectfully requests the Court for:

- 2 1. A Disposition Hearing for the unclaimed property on the SRPD List; and
3 2. Publication of the Disposition Hearing date; and
4 3. An Order forfeiting the undisputed items on the SRPD List to the SRPD for
5 disposition; and
6 4. Order any other relief the Court deems just and proper.
